St Paul's Art on the Parish Green 2018 June 9 and 10

This is a fine arts and crafts show located at 1015 E. Main Street in historic downtown New Albany on the grounds of Indiana's oldest Episcopal church.

All proceeds will benefit one of St Paul's community ministries. In past years we have supported our community feeding program.

YOU ARE INVITED TO BE ONE OF APPROXIMATELY 80 EXHIBITORS AT THE ST. PAUL'S ART ON THE PARISH GREEN. This application contains detailed information on participation. Please review it carefully before applying.

MISSION STATEMENT

The mission of St. Paul's Art on the Parish Green is to showcase arts and crafts, to connect artists with the buying community, and to promote our commitment to the arts and our local community.

Reminder: In consideration of our guests, this event is tobacco free.

GENERAL INFORMATION

St Paul's Art on the Parish Green is a two day showcase of visual arts and crafts. Additional activities during Art on the Parish Green include live performing acts and a children's art activities tent. Outdoor booth spaces are designed for a 10' x 10' show tents. Your booth may be on grass or pavement. Corner weights for the outdoor booths are highly recommended. A limited number of indoor spaces are available in the Carriage House; however, these spaces are irregular in shape and are smaller than 10 x 10. For the indoor spaces, all displays must be contained within the marked lines. Note: These indoor spots are usually occupied by returning artists and there is always a waiting list. Per a fire marshal visit, for safety reasons, all outdoor booths must contain a fire extinguisher. It should be a 'general use' fire extinguisher (minimum size is 5 lb).

PUBLICITY

Bookmarks will be produced and made available to participating artists to send/share with your customers. Numerous avenues of publicity such as web, Facebook, newspapers, etc. will advertise the art show.

BOOTH REQUIREMENTS

Show tents are recommended for the booths, but not required. White tents are preferred. The appearance of your booth is essential to promote your work and enhance the overall appearance of the show. Remember the sides and back of another booth will be visible in your booth. **All**

tables must be skirted to the floor or ground. Nothing may be attached to any walls or windows of the permanent structures on our property. Outdoor electricity will be available for all booths. Please bring your own heavy duty extension cords. A fan is suggested. Two artists may share a booth, but must submit photos for review and approval separately and both must be accepted. If you are selling several different mediums, each medium must be reviewed.

INSURANCE AND SALES TAX

Each artist is responsible for obtaining his or her own insurance. Neither St Paul's Episcopal Church nor any representative of the parish will be responsible for any losses or damage to any work exhibited or property brought to the Art Show. Each artist will be responsible for paying sales tax to the state of Indiana.

REFRESHMENTS

Exhibitors will be offered complimentary coffee and pastries one hour prior to opening on Saturday.

SECURITY

Security will be provided throughout the night from set up to tear down.

HOW TO APPLY

Artists must submit separate applications even if they plan on sharing a booth.

Those artists who want to exhibit in multiple categories must apply separately in each category and those artists whose work is accepted in multiple categories must exhibit in only one booth space unless paying for multiple booth spaces. Only those mediums that have been accepted may be shown.

DIGITAL PHOTOS

A total of 3 photos (4" x 6" prints or 300dpi digital images on a cd) are required representative of the work to be shown at the show. Only digital images of your art will be considered for use in advertising on postcards, brochures, TV ads and the art show website. **We will select from the digital images of artists' works submitted and accepted into the show.** To be used in our advertising the photos must be of high quality. By submitting your images, you are giving the art committee permission to use images of your work on art show advertising.

Booth FEES

\$100 or \$90 if paid before March 1, 2018.

ACCEPTANCE

Upon acceptance notification, the booth fee will be deposited. Cancellations must be in writing and postmarked by April 1st. A \$25 cancellation fee will be charged. After April 1st there will be no refunds.

APPLICATION, REVIEW, AND NOTIFICATION DEADLINES

Application Deadline: April 1st 2018 or later if space is still available. Selection by Review committee: by April 15th. Notification by email.

SECURITY

Security will be on site all night on Friday and Saturday.

SHOW DATES AND SETUP

Friday, June 8: Check in 1 pm – 8 pm. Check in at the information booth on 11th street and pick up your art show information packet.

Saturday June 9: Check in 7am until 9am, booths are open 10am - 6pm.

Sunday June 10: Booths are open 11:30 a.m - 5pm. Publicity will say booths open at 12:00. Parishioners will begin milling around a little after 11:00 following the 10:00 service.

All are welcome to join us at 10:00 Sunday morning for our Jazz Mass.
